Legionella Risk Assessment

As an employer or organisation in control of any premises, you have an absolute legal duty to undertake a Legionella risk assessment. This duty is a requirement of the following legal framework:

The Health and Safety at Work etc Act 1974

The Management of Health and Safety at Work Regulations

More specifically, the Control of Substances Hazardous to Health Regulations 2002 (COSHH) and:

HSE Guidance, The Approved Code of Practice: Legionnaires' disease: The control of Legionella bacteria in water systems (ACoP)

The risk assessment doesn't have to be complicated but will determine the right precautions that maybe required to reduce the potential risk of exposure to Legionella.

Monitoring Contracts

From your site Legionella risk assessment a site specific monitoring schedule will be set up and followed which provides compliance with current HSE guidance for Legionella control.

Our site-specific schedules are designed to provide you with the peace of mind that can only come from knowing your site is following best practices for Legionella control. Whilst it may be necessary for you to make certain changes to the way that your systems are maintained in order to comply with these best practices, we do not expect our clients to completely reorganise their day-to-day business activities in order to fit in with the way that we work. Rather, we seek to tailor

our services to suit the specific needs of each individual customer at the same time as ensuring that any changes that may need to be made will cause a minimum of disruption.

Cleaning and disinfection services

Our cleaning and disinfection services are carried out by our in-house fully trained engineers, who follow specific method statements and procedures to ensure the work complies with the latest HSE guidance for legionella control and COSHH regulations.

Legionella Testing

We use UKAS accredited laboratories to carry out Legionella testing, Sampling can provide valuable information on the efficacy of the control scheme, of which pre-planned maintenance (PPM's) such as temperature monitoring etc may form a part of.

Showerhead Cleaning and Disinfection

Showerheads and hoses require cleaning and descaling 4 times per year in accordance with the Health and Safety Executives guidance the ACOP in regard to legionella control.

The shower head needs to be dismantled so that all the removable parts can be cleaned and descaled. This includes the head, inserts and hoses.

Water Quality Testing

Drinking water in our workplaces is delivered in different ways, from taps to bottled dispensers, vending machines and water fountains. Maintaining that quality is important to not just the health of the workforce but the systems and processes that rely on water too. Water is also used for washing, cleaning, sanitation, heating and cooling, irrigation and a whole host of other processes. Like drinking water, it also needs to be of the right quality, whether microbiological (total viable counts (TVC), potable water testing, chemical, metal or other via a UKAS accredited laboratory.
